Collection Development Policy

Purpose

The Two Peas in a Pod Health Clinic collection supports the office staff including nurse practitioners, nurses, medical assistances, and a variety of health science students. The collection strives to acquire materials to meet user need related to education, research and clinical practice. The collection supports those currently practicing in the medical field from the level of nurse practitioners to students beginning to explore careers in the health sciences.

Scope

Languages: The collection will focus on English language materials and English translations of materials from major European countries.

Geographical area: Materials may be acquired without regard for geographical location however they should be geared toward an American audience.

Chronological Periods: The collection will focus on current healthcare information and research materials. Materials should be no older than five years.

Types of Materials

All formats are included except, lecture notes, ephemera or reprints.

The reference collection includes all bibliographic data bases (print and electronic) bibliographies, handbooks, manuals, pharmacopoeias, encyclopedias, dictionaries, and resource books.

Retention of older material: When new copies arrive the old copies will be removed. No materials older than five years will be circulated.

Standing orders: Standing orders will be used for publications updated on a regular schedule such as The Red Book for infectious diseases and the Physicians' Desk Reference.

Multiple copies shall not be purchased.

Selection Criteria

1. Subject scope
2. Need

3. Readership, authoritative monographs or journals that report basic research and new findings in clinical medicine and nursing are a high priority. Periodicals that mainly provide case studies or descriptions of procedures will be acquired more selectively.
4. Bibliographic access, availability through indexing in secondary sources is extremely important.
5. Quality, as judged by the reputation of the authors or editors, their institutional affiliation, relationship to a professional society and up to date references.
6. Use or potential use
